Dear Mr. Wasserman and Mr. Infantino:

As the United States prepares to welcome the world for the 2026 FIFA World Cup and the 2028 Olympic and Paralympic Games, the scale and visibility of these events underscore the need for a national security posture that is both adaptive and unified. These events are expected to draw millions of athletes, spectators, dignitaries, and media, placing extraordinary demands on the Nation's homeland-security architecture. While these events will serve as important demonstrations of global cooperation and American leadership, they also present asymmetric security risks that require deliberate, coordinated action across government agencies and the private sector.

Recognizing the complexity of the security mission ahead, the House Committee on Homeland Security has established a bipartisan *Task Force on Enhancing Security for Special Events in the United States* (Task Force). The Task Force is charged with conducting rigorous oversight of federal planning and preparedness efforts in partnership with state, local, territorial, tribal, and private sector stakeholders. As part of this effort, the Task Force is holding a series of hearings and briefings to evaluate how security operations are being coordinated across agencies and how event organizers are contributing to a unified security strategy.

Accordingly, we write to request that each of your organizations designate a senior executive with direct responsibility for event security and coordination with U.S. government partners to testify at a public hearing before the Task Force, tentatively scheduled for Wednesday, September 17, 2025, at 2:00 p.m. in Washington, D.C. The hearing, titled "*From the World Cup to the Olympics: A Congressional Review of Security Preparations for Athletes, Spectators, Delegations, and Venues at Upcoming Sporting Events*," will examine the current state of interagency and inter-organizational coordination to protect high-profile venues and soft targets, safeguard international delegations and VIPs, mitigate cyber and drone threats, and ensure operational continuity in the event of a major disruption or attack.


This proceeding will build upon the Task Force's July 22 hearing, which reviewed lessons learned from recent mass-gathering incidents, and an interagency briefing held with the U.S. Secret Service, the Federal Bureau of Investigation, and Homeland Security Investigations. Having heard from federal, state, and local law enforcement partners, the Task Force now seeks to hear directly from event organizers to understand your security postures, planning assumptions, and expectations for coordination with law enforcement and other homeland security authorities.

We fully recognize the distinct governance structures and planning mandates under which each of your organizations operates. We also acknowledge that your organizations are bound by international obligations and multi-national stakeholder arrangements. Nevertheless, given the scale and significance of these events to the American public, and the implications they collectively pose for our homeland security, it is imperative that Congress receives testimony from the organizations entrusted with their execution. Your participation will provide essential insight into how public- and private-sector coordination is being operationalized in practice and will help inform the Task Force's ongoing oversight and potential legislative efforts to enhance the federal security posture for upcoming events.

To ensure appropriate planning for the hearing, we respectfully request that each organization confirm its designated witness no later than Friday, August 29, 2025, and provide the title of the individual selected to testify. Committee on Homeland Security Majority Staff will follow up to coordinate all logistical and scheduling details.
